

Dr. Tintle Seminar on Shar-Pei



Autoinflammatory Disease (SPAID)

Date: Wednesday October 5, 2016

Time: 1-3 p.m.

Location: Wyndham Garden York 2000 Loucks Road York, PA 17408

For almost two decades, the CSPCA has supported and been involved in research projects to discover why Shar-Pei are predisposed to unique health challenges. This has led to our current understanding of Shar-Pei Autoinflammatory Disease (SPAID). Dr. Linda Tintle, DVM has spearheaded these projects and been diligent in finding and collaborating with top researchers to achieve our goal of understanding the disease. Our ultimate goal is to use this knowledge to develop genetic tests that permit breeders to make informed decisions in their breeding programs that lead to better overall health for Chinese Shar-Pei.

We are very fortunate to have her dedication and expertise constantly working on the behalf of our breed. She has graciously agreed to present this seminar at our National Specialty Show. She will be updating us on all the latest research news as well as giving information on the genetic test that has been developed to assess individual risk for SPAID which includes Shar-Pei Fever, amyloidosis, otitis and cutaneous vesicular hyaluronosis (bubbles of mucin).

You will not want to miss this seminar whether you are a breeder or just interested in the health of the breed. Mark your calendars and plan your schedules so you can attend. Bring all your friends of Pei with you. If you live anywhere near York, Pennsylvania, invite your veterinarians to the seminar. Everyone is welcome.



If you haven't done so yet, please take a moment to fill in a health survey on each of your Shar-Pei.

We would like to see as many people participate as possible. Surveys only take about 5–10 minutes to fill out, and the information gathered in invaluable to knowing where to best spend our research dollars on health issues in the breed. You do not need to use the registered name of the dog. Call names will do or number them if you are filling out surveys on more than one dog.

For each health survey that is filled out, at the end of the year, the CSPCA will pay \$2 for each one to the CSPCA Rescue Fund and an additional \$2 per survey to the Chinese Shar-Pei Charitable Trust. Filling out the survey's helps not only know how to spend the research money but also in benefiting two of our programs.

Health Corner



PRESS RELEASE: Shar-Pei Trust funds Cornell testing for gene responsible for inflammatory disease ITHACA—A new test for a serious disease affecting the Chinese Shar-Pei dog breed will soon be available at the Cornell University College of Veterinary Medicine Animal Health Diagnostic Center (AHDC). The new capability is made possible by a gift from the Chinese Shar-Pei Charitable Trust, which has donated \$50,000 toward the purchase of advanced testing equipment.

The Shar-Pei is a medium-sized, short-haired dog with a distinctive, slightly oversized head and excess skin that falls in folds around its face and back. There are about 20,000 Shar-Pei in the United States—and most of them carry the gene that puts them at risk for Shar-Pei Autoinflammatory Disease (SPAID). Dogs with a copy of the mutated gene from each parent are at extremely high risk for the disease.

SPAID is the first spontaneously occurring autoinflammatory disease to be described in animals. Severe cases are characterized by recurrent symptoms of inflammation: fever; swollen, painful joints; a condition that causes bubbles containing a clear, jellylike substance on the skin; ear problems and kidney failure. Dogs with SPAID may experience one or more of these problems. There is no vaccine or cure for SPAID, but with veterinary assistance owners can provide their dogs with some relief from the symptoms.

The new test, using droplet digital PCR (ddPCR), measures the number of copies of the faulty gene in individual Shar-Pei. It was developed by scientists in Sweden and the United States, including Dr. Linda Tintle, a Cornell veterinary college alumna. The group has spent years unraveling SPAID, first discovering the relevant gene in 2011. They announced their success with ddPCR last spring in BMC Genomics. So far, only Cornell's AHDC and SLU, the Swedish University of Agricultural Sciences, will offer testing for SPAID.

Dr. Tintle, who first began researching SPAID with Cornell immunologists in the 1980s, said positive test results serve two important purposes: "As a health tool, alerting owners to watch their dogs carefully for signs of SPAID, and as a breeding tool, with the aim of reducing the presence of SPAID in the worldwide Shar-Pei population" by not breeding dogs at high risk for SPAID.

The test also may prove useful in studying inflammatory diseases in humans. "Cornell's agreement to join in collaborative research into the syndrome will help us learn more about how to help relieve suffering in these dogs and others with inflammatory diseases," said Dr. Tintle.

"On behalf of our Trustees and donors, I am pleased to announce this gift," said Lee Arnold, Chairman of the Chinese Shar-Pei Charitable Trust. "We are indebted to Dr. Linda Tintle and her team for their groundbreaking research. This will be most beneficial for our breeders and owners for their future breeding programs."

"We are very pleased to make this new assay available to the Shar-Pei breeders in the US, in collaboration with Dr. Tintle and her colleagues at the Swedish University of Agricultural Sciences," says Dr. Amy Glaser, Director of Molecular Diagnostics at the AHDC. "We look forward to being able to provide this assay as a service to the community and to ongoing collaborative efforts with our colleagues in Sweden. We are grateful for this gift that makes this collaboration possible."

Introduction to a New Kidney Test: IDEXX SMA Test™

Thank you to member Jeanie Taber for sharing this information on the member's list.

The new standard of care from IDEXX Symmetric dimethylarginine (SDMA) is a new renal biomarker that should be run alongside creatinine, BUN, and a urinalysis to help diagnose kidney disease earlier and with more confidence. SDMA is a methylated form of the amino acid arginine, which is released into the circulation during protein degradation and is excreted by the kidneys.

There are three key attributes of SDMA:

- SDMA is a biomarker for kidney function. Because SDMA is almost exclusively eliminated by renal filtration, it is a good estimate of glomerular filtration rate (GFR). It can be used along with creatinine, BUN, and urinalysis to evaluate kidney function.
- SDMA increases earlier than creatinine in CKD. SDMA increases on average with 40% loss of kidney function versus creatinine, which does not increase until 75% of kidney function is lost.1
- SDMA is specific for kidney function. SDMA is not impacted by extrarenal factors that impact creatinine. In particular, it is not impacted by lean body mass and, therefore, will more accurately reflect GFR in underweight dogs and cats (e.g., geriatric and cachectic animals).

Chronic kidney disease is a common condition in dogs and a leading cause of death in cats. The IDEXX SDMA™ Test helps identify disease earlier and is complementary to existing kidney tests. Early identification should prompt investigation for an underlying cause, giving the potential for specific treatment. Early management may slow the progression of the disease. Closer monitoring will help identify progression and indicate when additional therapies should be initiated.




Jammers

Photographing & Videotaping at AKC Events

To protect the interest of the American Kennel Club the following policy has been approved to be effective immediately:

By submitting an application for and receiving approval to hold an event under the rules of the American Kennel Club, the club grants American Kennel Club, its employees, agents, licensees and others working for it or on its behalf the unlimited, irrevocable access, right and authority to photograph, record, film and/or videotape at the event. The club agrees that it has not and will not enter into any arrangement or agreement with any other party that will prohibit or prevent the American Kennel Club from exercising this right.

Group Clubs Supporting Entries at All-Breed Events

The Board approved a policy which will allow Group Clubs to support the entries of all the breeds in that group at an All-Breed Club's event. Supporting an breed or group at an All-Breed event requires approval by the All-Breed club holding the event. This is a way the local all-breed and group clubs to work together to build entries and foster comradery.

Helpful Notice To Clubs Regarding Cyber Attacks

Recently some of our Clubs were victimized by a "spear phishing" attack. Spear phishing attempts are customized emails that target a specific individual (often executives) and can come from anyone. They usually convey a sense of urgency and are requesting a specific action to be done. For example, the email may appear to come from the Club President to the Treasurer requesting a wire transfer to a 3rd party.

If you receive any emails of this nature, you should immediately confirm the authenticity of the email with the person from whom it was supposedly sent. Do not do this by replying to the email, as it may go right back to the hacker and can subject you to the possibility of further cyber-attacks. Instead, call the person directly who allegedly sent the email. If you are unable to reach them, wait until you do, prior to transferring any money or completing any action. Sophisticated hackers access the calendars of their targets and will often send the attack email when they know the person they are impersonating is traveling or otherwise difficult to reach.

If you receive any suspicious email, we recommend you immediately delete the email and advise your fellow officers, without replying to the original e mail.

AKC Agility Suspends Use of the Collapsed Tunnel

This past week, The American Kennel Club Agility department held their annual field representative meeting. During the meeting, the staff reviewed concerns raised by the Agility community involving the collapsed tunnel. This obstacle has been shown to cause issues as performances have become faster and higher level classes have become more complex.

After their review, the Agility Field Representatives agreed unanimously to suspend the use of the collapsed tunnel effective immediately. Based upon the Agility department's recommendation, Sports and Events Senior Management contacted the AKC Board of Directors to request immediate action. The Board concurred that the concern regarding the safety of the dogs was the first priority.

As of August 30, 2016, the AKC will suspend the use of the collapsed tunnel in all courses until the concerns can be resolved. Judges will be contacted by their Field Representative to review how to adopt this immediate change. Thank you to the Agility community for working in partnership with the AKC to bring positive changes to our sport.

Dear members,

Please find below procedures recently approved by the Board for an individual that wishes to hold a CSPCA specialty show.

Any individual who is a member in good standing with CSPCA wanting to hold a specialty in the CSPCA name is required to fill out a Specialty Dog Show form to be considered for approval at least 60 days before the applications are due to AKC. The AKC form must also be filled out in its entirety. (images.akc.org/pdf/events/AEVT02.pdf?_ga=1.193101931.718980089.1405347566)

All forms should be sent to Dorothy Schuerman, Specialty Show Chair at *onapei@aol.com*Any individual wanting to hold a specialty in the CSPCA name must obtain written permission from local Specialty Club(s) if the show is within an already approved Specialty Clubs territory of 75 miles.

Any checks made out to the CSPCA or to the individual for proceeds from a Specialty Show(s) must be turned in to the CSPCA Treasurer within 60 days of the date of the check.

Any reimbursement requested must be filled out on a CSPCA Reimbursement Form along with all pertinent receipts. The CSPCA will only reimburse expenses for the show from the proceeds of the Show(s). Any expenses over the proceeds will be the responsibility of the individual. Any profits made from the Show(s) will be distributed to The National Hospitality giving the individual/group credit for the donation.

The CSPCA will allow the individual to be under the umbrella of the CSPCA insurance for the Club Show(s), if no other option is available. Sportsman insurance charges \$50 to provide the umbrella policy to an individual CSPCA member and the fee is the responsibility of the individual and not CSPCA. The individual is responsible for completing the form with Sportsman insurance. If insurance is not obtained CSPCA reserves the right to withdraw sponsorship.
