Canine Good Citizen Committee

Formed 2/2012 to plan CGC tests at specialties and recognition for members of the CSPCA. This committee will work to increase awareness of an participation in the Canine Good Citizen Program.

For a Shar-Pei to be recognized as having passed a CGC Test, the owner must submit a copy of the dog's AKC CGC certificate or a copy of the test indicating they passed to the CGC Chairman. These dogs will get a one-time recognition in the Barker after they have provided proof of passing the test. CGC awards will be Certificates provided by CGC Chairman.

INSURANCE AD HOC COMMITTEE

For the past several years, the CSPCA's insurance portfolio has been coordinated by Jeff Vidt, DVM. Dr. Vidt is currently the only member directly involved with this responsibility. He has indicated an interest in stepping aside from this role and handing it to another CSPCA member. The members of the CSPCA extend great thanks to Dr. Vidt for his service to the CSPCA as the long standing Insurance Coordinator. The CSPCA Board is now seeking applications from qualified and interested applicants to replace Dr. Vidt and to Chair an Ad Hoc Insurance Committee. Please submit your expression of interest and qualifications to CSPCA Secretary, Melissa Castillo, no later than December 15, 2018.

This Ad Hoc Committee is responsible for researching and evaluating the CSPCA's current insurance coverage and providers. Current insurance coverage will be compared against recommended insurance requirements by this Committee. The Committee will also investigate potential insurance companies capable of providing the CSPCA with the proper insurance. This Committee will evaluate Insurance programs available for AKC Affiliated Clubs such as the CSPCA. This Committee will also evaluate potential insurance programs the CSPCA can make available to CSPCA Affiliated Clubs. There are currently 16 CSPCA Affiliated Clubs. This Committee will keep the CSPCA Board informed of this Committee's insurance related recommendations and suggestions on the insurance coverage the CSPCA and its Affiliated Clubs should maintain for their operation and protection. This Committee will be dissolved after its evaluation is completed and any findings and recommendations are communicated to the CSPCA Board. The CSPCA Board will approve any and all insurance coverage and providers based on recommendations from this Ad Hoc Committee. Once the Committee's recommendations have been reported to and acknowledged by the CSPCA Board, the Committee will be dissolved. The Long term coordination of the CSPCA's Insurance portfolio will be addressed at that time by the CSPCA Board in consultation with the Procurement Committee.

AKC FORUM PROGRAM

September 25, 2018

Why Insurance is important for clubs? Can your club survive a claim? No organization or individual is immune from allegations of being legally liable for their actions. Accidents involving injury to spectators or participants can arise out of club activities. Directors and officers can be held personally accountable for a loss which allegedly results from their decisions or acts on behalf of the club. Even if you are not found to be legally liable, defense costs can be significant.

- Always consult an insurance advisor regarding your specific coverage;
- Read your policy, especially the exclusions and understand your coverage; and
- Purchase coverage tailored specifically to dog club organizations.

Recommendation is that clubs have their own coverage for the year not just for one event. If coverage is for a year, it should cover meetings; Meet the Breeds at other events, vendors, personal property owned by the club, cyber breaches, transporting judges, rental car use for specific show or event. It is not recommended that one club share or allows other clubs use their policy. The club holding the policy does not know what the specialty club is doing. Do they rent equipment, transport judges, rescue or foster dogs, hold training classes in the name of the club that's insured, hire volunteers to assist at an event, do any type of ecommerce, and hold events for juniors? Third party slander is frequent reason club insurance is important especially in the age of social media. How are the members with access to the website using the information (identity theft)?

Event cancellation insurance is a separate or stand-alone policy and very expensive.

Equisure, Inc. is insurance for horse and dog clubs.

AKC DELEGATE MEETING

September 25, 2018 - Newark, NJ

The meeting was called to order by Dennis Sprung, President at 9:00 am.

Voting for committee members took place. Ballots were handed out for marking and placing in appropriate ballot boxes.

The meeting went into recess for the Forum a program regarding insurance for clubs.

The meeting was reconvened at 10:15 am.

Members on the dais were introduced – Ron Menaker, Chair; Dr. Tom Davies, Vice-Chair; Dennis Sprung, President; Gina DiNardo, Executive Secretary; and Parliamentarian.

New delegates were introduced. I did the honor of introducing Don Gillett as the newly seated delegate of the Troy KC.

Minutes from the June Delegate's Meeting, as appeared in the July Gazette were approved.

Two new clubs became member clubs to AKC – Lowton Dog Fanciers Association and Utah Valley KC.

President, Dennis Sprung gave the President's Report. It was a video of the new AKC office located at 101 Park Avenue, New York, NY.

Alan Fasual – AKC Museum of the Dog Director

He described, with pictures, of the new museum. There will be a number of interactive displays. An example is one in which your face is matched with a dog's face. Then you learn about that dog and exhibits of that breed are pointed out to you. In the end, you can purchase a photo of you and that breed at the gift show. The museum includes AKC history, all the art belonging to the AKC, a huge book library and breed achieves. The museum opens January, 2019.

Smart Pet (AKC LINK collar) was acquired by WAGS.

Joseph Buffoto, CFO reported the finances of AKC thru August 31, 2018.

Next on the agenda was to vote on proposed Amendment changed.

Rules Applying to Dog Shows – Chapter I, Section. A member of licensed show with a limited entry, at which championship points may be awarded, may be given by a club or association in the event said club or association considers it necessary to LIMIT the NUMBER OF DOGS or TOTAL ENTRY..... This proposal allows clubs to limit their event by the number of dogs or by the total entry. Proposal was voted on and received the 2/3's vote to pass.

Rules Applying to Dog Shows – Chapter 3, Section 16. Add: The Best in Show judge at an All-Breed Show shall first award Reserved Best in Show, followed by Best in Show. This proposal was voted on and failed. It did not receive the 2/3's vote to pass. (This procedure is present in another Chapter and Section.)

Rules Applying to Dog Shows – Chapter 5, Section 9. Add "Reserve Best In Show, and" to this section allowing a club to offer a three-time win trophy for Reserve Best In Show. Proposal was voted on and received the 2/3's vote to pass.

Rules Applying to Dog Shows – Chapter 16. Addresses types of inappropriate collars and leads at dog shows. After several additional amendments to changes in wording, delegates voted to send this proposal back to the committee for rework.

The following proposed amendment changes were read and will be voted on at the December 2018 meeting. Chapter 3, Section 13. Clarifies eligibility of Winners Dog/Bitch that has been defeated in a non-regular class.

Chapter 5, Section 2. Allows clubs the option to include or not to include the date on class placement ribbons.

Chapter 7, Section 1; Chapter 9, Section 2. Housekeeping to clarify the wording.

Chapter 9, Section 4. Broadens the requirement of forms Superintendents/Show Secretaries must have available.

Chapter 9, Section 12; Chapter 10, Section 8. Wording clarification.

Chapter 11, Section 1. Two proposed amendments – eligibility of foreign dogs and conditions of dog affecting eligibility.

Chapter 11, Section 8. Changes the italicized paragraph so it becomes a rule.

Chapter 11, Section 8-A. Permanent identification for disqualified dogs.

Chapter 14, Section 5. Show committee must provide digital scales in addition to wickets at shows.

Chapter 16, Section 1. Provides the Best of Winners the opportunity to earn one championship point if the combined number of regular class dogs for both sexes is the minimum required for one point (usually two competitor's total). I-I-I

Chapter 14, Sections 12, 12A, 13, 13A and 11A of Field Trial Rules. Regarding riding horses and walking trials.

The Nominating Committee was announced. There are three vacancies for the Class of 2023. Dr Michael Knight, Chair, Pamela Beale, Ross Jones, Louise Leone, Sylvia Thomas. Nancy Skoglund and Marilyn Vinson are Alternates. Nominating Committee must report its nominations to AKC before October 15, 2018.

The American Chesapeake Club was awarded a plaque for achieving 100 year milestone as a member in AKC.

Tom Sharp, Reunite reported on the 5-year anniversary.

\$1,059,000 - donated from clubs

\$246,000 - from individuals

\$450,000 - pledged from AKC

Reunite has donated \$750,000 to other shelter organizations for sheltering and rescuing dogs from disasters.

Gail LaBerge spoke briefly regarding contributing to AKC PAC.

Announced the passing of Herb Rosen, a Tibetan spaniel breeder and delegate.

Sylvia Thomas announced the deadline for the December, 2018 is October 22, 2018.

Delegate meeting was adjourned 1:00 pm.

If you miss this deadline, the next deadline will be March 15, 2019.






Scroll of Honor Reminder
