### AKC DELEGATE'S MEETING FRIDAY, DECEMBER 14, 2018 - ORLANDO, FL

The meeting was called to order by President, Dennis Sprung at 10:00 am. People on the dais were introduced.

Executive Secretary, Gina DiNardo, read the report of the Nominating Committee for the Class of 2023. Candidates nominated by the committee are: Dr. Thomas Davis, Dr. Charles Garvin and Daniel Smyth, Esq. Petitioning Candidates are: Steven Hamblin and Karen Burgess. The delegates present asked questions and candidate was given 3 minutes to respond.

New delegates were introduced.

Minutes of the September 25, 2018 were approved as submitted.

Two new member clubs were voted on - Lowchen Club of America and the Grand Basset Griffon Vendeen Club of America. Both received the required 4/5 vote of the delegates present and were approved.

Dennis Sprung thanked AKC staff and delegates for the work on the 18th AKC National Championship Show with over 9,000 entries.

Visionary Awards were presented to: Jane Wilkinson, Kathleen Gregory, Marjorie Tuff, Ann Lettis. Joseph Buffoto,

Amendment Vote -

Chapter 14, Sections 12, 12A, 13, 13A, and 11A - Field Trial Rules for National Open Walking Gun Dog Championship. - passed.

Chapter 3, Section 13 - Rules Applying to Dog Shows. Dog Show Classification clarifies the eligibility of Winners Dog/Bitch that has been defeated in a non-regular class as well as when the Best of Winners is awarded. Passed.

Chapter 5, Section 2 - Rules Applying to Dog Shows - Ribbons, Prizes and Trophies, allows clubs the option of including the date on class placement ribbons. Passed as amended.

Chapter 7, Section I - Rules Applying to Dog Shows - Judges, converts most of the italicized text to part of the rule while keeping one sentence regarding where eligibility is expanded in italics.

Chapter 9, Section 2 - Rules Applying to Dog Shows - Superintendents and Show Secretaries, takes italicized Board interpretation and makes it part of the rules. Additionally, it clarifies that an individual can only provide services for one all-breed or one group club in a calendar year. Passed

Chapter 9, Section 4 - Rules Applying to Dog Shows - Superintendents and Show Secretaries, broadens the requirements regarding which forms the Superintendents/Show Secretary must have available at events. All necessary forms are available on the AKC website or sent to the Superintendent/Show Secretary prior to the event. Passed as amended.

Chapter 9, Section 12 - Rules Applying to Dog Shows - Superintendents and Show Secretaries, cleans up

wording to provide clarity and adds a reference to eligibility requirement for this role. Passed.

Chapter 10, Section 8 - Rules Applying to Dog Shows - Duties and Responsibilities of Show Veterinarians, adds a reference to the eligibility requirement for this role. Passed as amended.

Chapter 11, Section 1 (Stud Book) - Rules Applying to Dog Shows - Dog Show Entries, Conditions of Dog Affecting Eligibility, brings the Rules up to date with the intent and current practices. Passed.

Chapter 11, Section 1 (Foreign Dog), - Rules Applying to Dog Shows - Dog Show Entries, Conditions of Dog Affecting Eligibility, adds clarity to a foreign dog's eligibility for a specific class without creating redundancy by listing the requirements. Passed.

Chapter 11, Section 8 - Rules Applying to Dog Shows - Dog Show Entries, Conditions of Dog Affecting Eligibility, changes the italicized paragraph to become part of the rule and add a clarification to the sweepstakes judge's abilities when these conditions are present. Passed.

Chapter 14, Section - Rules Applying to Dog Shows - Measuring, Weighing and Color Determinations - sent back to committee.

Chapter 16, Section I - Rules Applying to Dog Shows - Championships, provided the Best of Winners the opportunity to earn one championship point if the combined number of regular class dogs for both sexes is the minimum required for one point (usually two competitors total). Passed as amended.

Chapter 11, Section 8-A (DQ Changes) - Rules Applying to Dog Shows - Did not pass. Chapter 11, Section 8-A (Reinstatement) - Did not pass. Read for vote in March 2019:

Charter and Bylaws of the American Kennel Club, Article VIII, Section 1- regarding the Nominating Committee.

Charter and Bylaws of the American Kennel Club, Delegate Standing Rule on Committees, Section VI –regarding the Nominating Committee.

A video was shown regarding the AKC PAC.

March 11, 2019 is the Annual Meeting and election of Board Members. Delegates will be bused to a reception at the Museum of the Dog in Manhattan.

Meeting adjourned at 12:20 pm.

#### DELEGATE ADVOCACY AND ADVANCEMENT COMMITTEE (DAAC) 12/13/18

Dan Smyth, Chairman, discussed the Google Delegate List. There are over 600 AKC Member Clubs and to date only 392 Delegates have signed up.

New Delegate Orientation Program held in September was debriefed. The "speed dating" format was well received. Feedback suggested more time be allowed.

New Delegate Mentoring - Dick Blair reported that we had one New Delegate for October and six in November. A total of 24 Delegates attended the morning orientation.

Jane Ruthford reported that there has been no new request or ideas for the current video. No urgent need for a new video. Keith Frazier, AKC staff, reported that the video link exists on the home page of the Delegate Portal.

Ellen Hardin brought 25 name badges to the meeting. They are located on the table outside the Parent Club meeting room.

Website Improvement Committee - discussion of two new tools for AKC Marketplace. One tool to allow Clubs to update and eliminate those nonmembers who represent themselves as members of the parent club. The other tool will enable Clubs to upload images to be used across the AKC.

Ellen Hardin reported on the proposed Junior Scholarship Program. A vote to move forward on the cover page was held and passed . The open issue is funding.

No Old Business was reported.

#### New Business

The New Delegate Google Group E-List - a motion was made and passed unanimously regarding Guidelines for list use. Keith Frazier reported that AKC Committees now have folders to store their respective documents in the Google Group. New projects include: New Delegate Survival Guide and creating a Survival Kit (Go bag) for evacuees.

#### ALL BREED COMMITTEE MEETING THURSDAY, DECEMBER 13, 2018

Kathy Rubens gave an update on best Practices for Community Relations. The final findings should be completed by the March Meeting.

Glenn Lycan from Club Relations Department reported on updating check list for show chairs. He reminds us that his department is available to help with all aspects of putting on a show. They are there to help. He recommends shows try to expand events by adding Barn Hunt, Fast Cat and Dock Diving when possible. Most of these events are run by outside organizations or typically clubs for these events and the clubs share the profit.

Ashley Jaycott updated us on the Webinars that AKC provides. She encourages everyone to take advantage of them and reminded everyone that past presentations are available on the website. Also, the PATCH program for children is well received. There are 517 children over two days signed up for Canine Safety program and a scavenger hunt at the AKC Championship this weekend. Her department can assist us to plan these events at our show.

Jane Meyers presented a video developed by Field Rep Sue Vroom. It is an educational loop targeted to New Exhibitors that can run continuously at our show and explains how a dog show works. It is a great tool we can use. It should be available to all shortly.



**Agility Awards**- The AKC top agility dogs report only shows dogs competing at the highest level, so in order to receive recognition it is the responsibility of the owner/handler to keep up with the required information and submit it to the Agility Chairperson. You must send the information from each qualifying leg of a title—score, standard course time, actual time, and placement (if any) to the Agility Chairman by July I each year. **AKC Outstanding Sportsmanship Award-** Any CSPCA member in good standing or any CSPCA Affiliated club may nominate any CSPCA member in good standing for this award based on the AKC Code of Sportsmanship. # UPDATE ON THE BYLAWS

Dear CSPCA Members - The CSPCA Board is reviewing our bylaws and we plan to make some revisions in accordance with AKC recommendations. We have recently learned AKC has a new set of model bylaws recommended for AKC member clubs. As a result, the CSPCA Constitution and Bylaws Committee has initiated a review of our bylaws alongside AKC's model bylaws. Once that review is complete and the Board has had a chance to review the Committee's proposed revised bylaws, we will be moving forward in accordance with our existing bylaws, which state in Article VIII - "The bylaws ...... may be amended at any time provided a copy of the proposed amendment has been published in The Barker and sent to each member in good standing on the date of publication, accompanied by a ballot on which he may indicate his choice for or against the action to be taken....... The favorable vote of two-thirds of the members in good standing who return valid ballots within the time limit shall be required to affect any such amendment. No amendment to the bylaws or to the Standard for the Breed that is adopted by the Club shall become effective until it has been approved by the Board of Directors of The American Kennel Club." Hence, the full membership of the CSPCA will get an opportunity to review the bylaws and vote on the revisions before they are sent to AKC for final approval.
